**When:** Sunday, September 23, 2007

**Where:** Workin' Paws, 690 Tevis Trail, Hollister, CA. [www.workinpaws.com](http://www.workinpaws.com)

**Time:** First walk through at 8:30am

**Cost:** Pre-Entry: \$25.00 for the 1<sup>st</sup> dog, \$10 for 2<sup>nd</sup> dog, \$5 each additional dog. **Unlimited runs per person** regardless of number of dogs. Entries must be received by Friday September, 21, 2007.

Day-Of Entry: \$40.00 for the 1<sup>st</sup> dog, \$10 for 2<sup>nd</sup> dog, \$5 each additional dog.

**Weather:** Checks will not be cashed before the day of the fun match; they will be destroyed if the weather is stormy. If the weather is questionable, an email will be sent. **Limited to the first 50 people.**

This match is to provide handlers and dogs an opportunity to practice. It is not for competition. Teats and toys in the ring are encouraged. Jump heights are at your discretion. We do ask that your dog have agility experience and be able to use the equipment safely off leash. There is limited shade so bring shade, an X-pen or crate. **PLEASE NOTE THE FOLLOWING CHANGE:** Within a jump height, running order will be based on sign up at ring side. If you miss your run time, you must run at the end of your jump height. There will be a ninety second maximum time in the ring for each run. Please only run **once** during your jump height, we will rotate again through jump heights.

**From the South Bay:** 101 South, Take CA-25 go 4 miles. Turn Left on Shore Road go 3.8 miles; Shore Road turns into Fairview-go 3.3 miles. Turn Left on Spring Grove- go 1 mile, Turn Left on Tevis Trail. Tevis Trail is a loop-you may take the first Left if you wish. The house # 690 Tevis Trail. **From the Monterey Peninsula/Salinas:** 101 North, Take the CA-156 East toward San Juan Bautista-go 15.5 miles. Turn Right on Fairview Road-go 1.9 miles. Turn Left on Spring Grove- go 1 mile and Turn Left on Tevis Trail. Tevis Trail is a loop-you may take the first Left if you wish. The house # 690 Tevis Trail. **From Highway 5 North or South:** Take 152 West toward Gilroy-go 13.2 miles, CA-152 West becomes Pacheco Pass Hwy-go 15.6. Turn Left on Fairview Road-go 1.9 miles. Turn Left on Spring Grove- go 1 mile and Turn Left on Tevis Trail. Tevis Trail is a loop-you may take the first Left if you wish. The house # 690 Tevis Trail

I take full responsibility for all my actions or inactions, those of my dog, and those in my charge hereby holding Workin' Paws LLC, fully harmless at all times. I understand that my dog must be healthy, up-to-date on shots, rabies be current, and have flea & tick protection prior to arrival. X-pens are allowed provided my dog can not escape, but crates are to be used when my dog is not supervised. I understand no excessive crate barking will be accepted. I understand that should my dog injure any live stock I am responsible for the medical fees, or replacement, as decided by Workin' Paws. I understand that my dog must be under control at all times and liability will fall upon me for any actions or inactions resulting in injury, death, or illness. I am over eighteen years of age and hereby consent by my signature below to the terms of this Hold Harmless Agreement.
