**Time:** First walk through at 8:30 am

**Cost:** Pre-Entry: \$25.00 for the 1<sup>st</sup> dog, \$10 for 2<sup>nd</sup> dog, \$5 each additional dog. **Unlimited runs per person** regardless of number of dogs. Entries must be received by the Friday before the match.

Day-Of Entry: \$40.00 for the 1<sup>st</sup> dog, \$10 for 2<sup>nd</sup> dog, \$5 each additional dog.

**Weather:** Checks will not be cashed before the day of the fun match; they will be destroyed if the weather is stormy. If the weather is questionable, an email will be sent.

**Limited to the first 35 people.**

**Requirements:** This match is designed to prepare your dog for competition. Your dog should be at least a year old, have at least 6 months of agility training, be able to perform all obstacles safely, have a good recall, and be nearly ready to compete (talk to your trainer about what your dog is ready for). Any dog can run at any jump height (Great Danes at 12", if you like). Treats and toys are allowed in the ring, but PLEASE do your best not to drop food that will distract other dogs! Dogs must run collarless or in flat buckle collars, no attachments; dogs may not run with leashes on. No equipment familiarization. Limited shade so bring shade, an X-pen or crate, and treats and water for your dog.

**Prohibited** and grounds for excuse without refund: Dogs that are aggressive in any way toward people or other dogs; any harsh corrections, either physical or verbal; pinch collars and bark collars; or dogs that bark *excessively* in crates or cars.

Directions to Workin' Paws from the North : 101 South, Take CA-25 go 4 miles. Turn left on Shore Road, go 3.8 miles, and Shore Road turns into Fairview. Go 3.3 miles further and turn left on Spring Grove; go 1 mile, Turn left on Tevis Trail. Tevis Trail is a loop: you may take the first left if you wish. The house # 690 Tevis Trail. OK to park on front grass only after the parking lot is full. There is an arena area in the back for people to run their dogs; just pick up after your dog in the arena. Please keep away from livestock, and beware the dog-enticing ground squirrel holes next to the mare motel.

Directions from the South: 101 N, take Hollister 156 exit and follow it to Fairview road. Do NOT turn into Hollister, stay on 156. Turn right at Fairview, left on Spring Grove, go one mile and then left on Tevis Trail. The house is #690 Tevis Trail.
